

WHY DIGITAL REVENUE MOBILIZATION ??

Tanzania local authorities is governed by CAP 290 of the Laws and as regulated by Local bylaws. Revenue sources those are to be collected provided by section 6,7 and 8 for Urban, districts and village Councils respective. Many Tanzania LGA'S fail to meet her expected Annual Collections due to the following reasons:

- Poor Transportation logistics to municipal offices
- Long queue of people during payment season
- Lack of voluntary culture of paying revenue
- Awareness on taxation periods
- Lack of resources such as cars, public address for every ward for mobilizing people to pay taxes
- Most of local taxes are difficult to collect, and not cost effective


